



# Call for Papers Contest Award in Economics, Finance and Development 2008



Professionals and students from different educational levels, both national and foreign, are encouraged to participate. Individual authors or co-authors (maximum four) can participate. Neither active and ex-civil servants of Central Bank of Nicaragua (CBN), nor members of the jury, nor winners of previous calls of the contest are allowed to participate.

The studies must be about Nicaragua or include the country as part of the analysis. The studies may address topics of economics, finance, and socioeconomic issues relevant for the development of the country that contribute to understand and explain the causes, consequences and the drivers of change for the development of Nicaragua.

Research papers should be original and submitted in English or Spanish. Studies submitted to previous editions of the contest will not be accepted. Abstracts of B.Sc. thesis, master thesis and doctorate thesis written in the last five years will be accepted. Thesis abstracts should quote in the text and references the original thesis. The studies should be previously unpublished, nor in process of being published, nor in process of acceptance in another contest. The only published studies to be accepted are those published in the thesis repertories of universities.

The document format should be single line spacing, font Times New Roman size 12, maximum length of 40 pages, including a summary of 150 words. A pseudonym should be included in the cover page in order to replace the name of author or co-authors.

**Registration** and upload of required documents must be done through the website of the contest: [www.bcn.gob.ni](http://www.bcn.gob.ni) as of **July 2<sup>nd</sup>, 2018** until 17:00 hrs Nicaragua time zone (UTC-6) of **September 17<sup>th</sup>, 2018**.

In order to participate in this contest, the necessary information will be required in a digital **registration** form i.e. name, pseudonym, address,

identification document, among others. Once the number of authors has been placed, boxes necessary to provide the information of each author will be displayed. The documents must be uploaded only in PDF-format. No studies will be accepted physically or in any other way than through the abovementioned website.

Participation in this contest is free of charge. The CBN does not accept payments for registration or disbursements of any kind. The CBN does not assume costs or reimbursements for carrying out the research and presenting the results.

Papers without a pseudonym or any other reference suggesting the identity of the author or co-authors will be disqualified. Likewise, studies containing plagiarism will be subjected to immediate disqualification of the contest.

The winner of the first prize will get C\$100,000.00 (one-hundred thousand Córdobas) plus a certificate of recognition.

The winner of the second prize will get C\$75,000.00 (seventy-five thousand Córdobas) plus a certificate of recognition.

The winner of the third prize will get C\$50,000.00 (fifty thousand Córdobas) plus a certificate of recognition.

The above mentioned monetary awards are subjected to tax withholding in line with Article No. 87, Law No. 822.

Special mentions may be awarded. If that is the case, participants will receive a certificate of recognition.

The winning studies will become a property of CBN.
